Imagine my shock to see the way it has been covered by the Mainstream Media...  
...and, even worse, how the Democrats have exploited it to grab power...**

**Those in power and their media allies have completely disconnected from reality...  
Or rather, they are trying to reshape reality to fit their agendas...**

**What is most alarming is that the Mainstream Media's false narratives...  
...are all that most of the country has to go on to understand what happened...**

**In reality, the Democrats and the Mainstream Media now attempting a coup against our President...**

**For this reason I feel it is imperative to write down what actually happened as a permanent record...  
Please forward this recording of the day's events and what happened afterwards to others...**

...so that people know the *real* story...

...and not the hostile propaganda put out by Democrats and their media allies...

The questions today's *Freedom Update* seeks to answer are...

- 1) From an eye-witness viewpoint, what actually happened?
- 2) How has the Save America Rally been covered?

## What actually happened?

At the outset, let me make a few observations about the ralliers...

...which you can verify for yourself by looking at the photos...

Notice the age of the people... This was not a mob of belligerent young punks...

Typically, the people around me were in their 30s, 40s, 50s, 60s, and 70s...

There were *lots* of graybeards...

The group I was with consisted of me (aged 59) and two 70+ year olds...

Next, get a grasp of the size of the gathering...

When our group arrived at about 10am...

...the National Mall was already filled out beyond the Washington Monument...

...which, according to [this crowd estimator](#), means the crowd was about a million strong...

Next, consider the fatigue of the ralliers....

Our group stood near the Washington Monument, as you can see in the photo...

Everyone who stood closer to the Capitol Building had gotten there before us...

Many were there for *hours* before us...

In fact, some had been there all night...

Also, people continued to fill in after we arrived, going past the Washington Monument...

There were a number of preliminary speeches...

...the most important of which were made by Rudy Giuliani...

...who laid out the legal strategy for stopping Biden from being declared president...

...and Professor John Eastman, who described how the Georgia runoff elections...

...had been stolen through blatant use of the same tricks applied in November...

President Trump began speaking at noon and did not finish until about 1:15pm...

He ended by saying that it was time for us to walk to the Capitol and encourage VP Pence & Congress

...to do the right thing by demonstrating to them that The People supported election integrity...

Throughout this entire time, there was no food or water available...

In fact, I myself had nothing to eat between 8am and 5pm... The day was *exhausting*...

After having stood near the Washington Monument for two-and-a-quarter hours...

...all of us walked to the base of the Capitol Building...

That is a *long* walk for people who had stood for hours... about a *mile*...

My reason for saying all of this is to point out that by the time we reached the Capitol...

...few if any people were in a physical condition for rabble rousing...

Personally, my back was killing me from standing for over 4 hours, with intermittent spasms...

...and one of my group members tripped and fell, due to his exhaustion...

Fortunately, he fell into me... He knocked me to the ground but I broke his fall so no one got hurt...

At about 2:30pm, word went out that VP Pence had chickened out...

...on doing the strategy outlined by Giuliani...

At that point, the mood in the group turned sour...  
Everyone was upset, and people began making a lot of noise...  
That was when some people began climbing up the scaffolding...  
...that had been set up, presumably for President Trump's rally...  
...though I can't be sure because I watched the speakers on a screen and not in person...

You can see people standing on the scaffolding in the background of the photo of me above...

Police were standing at the edge of the Capitol Building near the top of the scaffolding...  
...making sure that no one actually stepped onto the Capitol Building...  
In other words, *the police let the scaffolding be available* to the ralliers...  
...and clearly marked off where people *could not* go, by means of their physical presence...  
If the police had wanted to, they could have easily stood *in front of* the scaffolding...

At about this time, I had to go to the bathroom...  
...so I stepped into a temporary bathroom building to stand in line...  
While standing there, tear gas was evidently used by the police on some protestors...  
Some of the gas wafted into the building, making some of us cough...  
This led to a joke...  
"And where were *you* during the revolution? Well, I was standing in line waiting for the toilet"...

After that, I came out, rejoined my group, and we stood around for another 45 minutes...  
...but since Pence had already decided to count the original elector envelopes...  
...there wasn't much point to the rally any more...  
...so at 3:30 we began walking toward the Metro.

However, shortly before we began walking...  
...we heard from another rallier that a woman had been shot...  
Later, as we were walking toward the Metro, we met a woman, probably in her mid-40s...  
...who claimed to have been an eye-witness to the shooting...  
She said that the woman was a tiny person who couldn't have weighed more than 90 pounds...  
She hadn't represented a threat to *anyone*...  
The woman speaking to us was shocked that the police had shot her...

As we continued walking toward the Metro...  
...we saw a long train of police cars and police *busses* (for mass arrests?)...  
...zooming past us with sirens blaring...

Apparently, the city was *determined* to make it look like some catastrophic event had occurred...  
The mayor imposed a 6pm curfew on not just Washington DC...  
...but also Arlington and Alexandria...  
I felt lucky to be able to get out before being locked down...  
As I was driving home, my Apple Watch was vibrating with warnings that the lockdown was in force...

While driving, I started getting calls from concerned friends...  
...worried that something might have happened to me...  
...and telling me about the "insurrection" that was being reported...  
The news reports they told me of...  
...sounded *nothing* like the event I had just participated in... More on that later...

Rudy Giuliani gave a speech at Donald Trump's "Save America" rally on January 6, before Trump protestors stormed the Capitol building in a riot. Giuliani said, "Let's have trial by combat," in his speech. Read the full transcript here.

Rudy Giuliani: ([00:09](#))

Hello. Hello everyone. We're here just very briefly to make a very important two points. Number one; **every single thing that has been outlined as the plan for today is perfectly legal. I have Professor Eastman here with me to say a few words about that. He's one of the preeminent constitutional scholars in the United States. It is perfectly appropriate given the questionable constitutionality of the Election Counting Act of 1887 that the Vice President can cast it aside and he can do what a president called Jefferson did when he was Vice President. He can decide on the validity of these crooked ballots, or he can send it back to the legislators, give them five to 10 days to finally finish the work. We now have letters from five legislators begging us to do that. They're asking us. Georgia, Pennsylvania, Arizona, Wisconsin, and one other coming in.**

It seems to me, we don't want to find out three weeks from now even more proof that this election was stolen, do we?

**So it is perfectly reasonable and fair to get 10 days... and you should know this, the Democrats and their allies have not allowed us to see one machine, or one paper ballot. Now if they ran such a clean election, why wouldn't they make all the machines available immediately? If they ran such a clean election, they'd have you come in and look at the paper ballots. Who hides evidence? Criminals hide evidence. Not honest people.**

**Over the next 10 days, we get to see the machines that are crooked, the ballots that are fraudulent, and if we're wrong, we will be made fools of. But if we're right, a lot of them will go to jail. Let's have trial by combat. I'm willing to stake my reputation, the President is willing to stake his reputation, on the fact that we're going to find criminality there.**

Is Joe Biden willing to stake his reputation that there's no crime there? No. Also, last night one of the experts that has examined these crooked dominion machines has absolutely what he believes is conclusive proof that in the last 10%, 15% of the vote counted, the votes were deliberately changed. Donald Trump spoke at a "Save America" rally in Washington, D.C. on January 6 before Congress was set to confirm the election results. "We will never concede," he said. Read the transcript of his speech remarks here.

Donald Trump: (02:44)

The media will not show the magnitude of this crowd. Even I, when I turned on today, I looked, and I saw thousands of people here, but you don't see hundreds of thousands of people behind you because they **(the media camera crews, which were not taking any pictures of the huge crowd)** don't want to show that. We have hundreds of thousands of people here, and I just want them to be recognized by the fake news media. Turn your cameras please and show what's really happening out here because these people are not going to take it any longer. They're not going to take it any longer. Go ahead. Turn your cameras, please. Would you show? They came from all over the world, actually, but they came from all over our country. I just really want to see what they do. I just want to see how they covered. I've never seen anything like it. But it would be really great if we could be covered fairly by the media. **The media is the biggest problem we have as far as I'm concerned, single biggest problem, the fake news and the big tech.** Big tech is now coming into their own. We beat them four years ago. We surprised them. We took them by surprise and this year, they rigged an election. They rigged it like they've never rigged an election before. By the way, last night, they didn't do a bad job either, if you notice. I'm honest. I just, again, I want to thank you. It's just a great honor to have this kind of crowd and to be before you. Hundreds of thousands of American patriots are committed to the honesty of our elections and the

integrity of our glorious Republic. All of us here today do not want to see our election victory stolen by emboldened radical left Democrats, which is what they're doing and stolen by the fake news media. That's what they've done and what they're doing. We will never give up. We will never concede, it doesn't happen. You don't concede when there's theft involved.

Our country. Our country has been under siege for a long time, far longer than this four-year period. We've set it on a much straighter course...

Well, his rates are so low, his approval rating now, I think it just reached a record low. They've rejected five separate appeals for an independent and comprehensive audit of signatures in Fulton County. Even without an audit, the number of fraudulent ballots that we've identified across the state is staggering. Over 10,300 ballots in Georgia were cast by individuals whose names and dates of birth match Georgia residents who died in 2020 and prior to the election. More than 2,500 ballots were cast by individuals whose names and dates of birth match incarcerated felons in Georgia prison. People who are not allowed to vote. More than 4,500 illegal ballots were cast by individuals who do not appear on the state's own voter rolls. Over 18,000 illegal ballots were cast by individuals who registered to vote using an address listed as vacant, according to the postal service. At least 88,000 ballots in Georgia were cast by people whose registrations were illegally backdated.

The President Trump supporter [killed in the Capitol building Wednesday](#) was an Air Force vet from California who tweeted a day earlier how "nothing will stop us" and "the storm is here."

Ashli Babbitt, who had 14 years in the service and did four tours of duty, was married and lived near San Diego, her husband, Aaron, [told KUSI-TV](#).

"I'm numb. I'm devastated. Nobody from DC notified my son and we found out on TV," the husband's mother, Robin Babbitt, told The Post, saying of her daughter-in-law, "She is a Trump supporter."

Everything is "pretty surreal," added Aaron's brother, Justin. "It's hard, because we haven't been officially notified."

The day before she [was fatally shot](#), apparently by Capitol Police, [Babbitt tweeted](#), "Nothing will stop us... they can try and try and try but the storm is here and it is descending upon DC in less than 24 hours....dark to light."

Babbitt, who used the Twitter handle CommonAshSense, [also retweeted Wednesday](#) morning — a few hours before she and other Trump supporters stormed the Capitol — a "MUST BE DONE LIST before Congress meets today."

It included, "Mike Pence@vp @Mike\_Pence must resign & thereafter be charged with TREASON," and, "Chief Justice John Roberts must RESIGN."

The rioters were protesting Congress' impending certification of Joe Biden as the winner of the 2020 presidential election.

Babbitt took a fatal bullet to the chest during the mayhem inside the Capitol.

Video footage captured the sound of the gunshot, and showed the woman crumpling to the floor from multiple angles.

She apparently was shot by Capitol Police, law enforcement sources told The Post.

[Responding to a tweet](#) Monday by conservative author Melissa Tate saying, "Landing in DC. Here to do God's work. Save the Republic," [Babbitt responded](#), "I will be there tomorrow! Gods speed!"

On Tuesday, Babbitt retweeted TV footage of a pro-Trump crowd massing in DC ahead of Wednesday's riots.

Babbitt's mother-in-law told a Fox affiliate in DC she was puzzled by the behavior of her son's wife.

SANDY — A Utah activist who faces criminal charges in connection with a Provo protest he organized in June said he attended a pro-Trump rally that turned into a violent attack on the U.S. Capitol in order to see “the truth” about the protests for himself and the organization he represents.

“For me, it’s important from the group and the people around me to see that side of things, to see the truth,” John Sullivan said Wednesday night. “I don’t care, like what side you’re on, you should just see it raw.”

Sullivan, who is the founder of **Insurgence USA**, a social justice group that calls itself anti-fascist and protests police brutality, said he also intended to “support the Black community” with his attendance, but also feels it’s “important to understand” those who were protesting in support of President Donald Trump. He said he was on the “front lines” of the protest as it turned from a peaceful march into a violent storming of the Capitol.

He said he followed online conversations about Wednesday’s protest, which coincided with a rally by the president and the counting of the country’s electoral votes in a joint session of Congress. That largely ceremonial act was interrupted Wednesday afternoon when hundreds of protesters pushed past Capitol Police and metal barricades, broke out windows and smashed open doors to gain entry into the building.

That was not an impromptu act, Sullivan said.

“As far as them storming the Capitol, I knew that was going to happen,” he said. “I’m on chats that are underground that are sending out flyers that are just like, ‘Storm all Capitols on the 6th.’ It wasn’t anything that was secret. It was something that was out there ... and they did it.”

**Sullivan said he also made his way inside the Capitol during the riot and witnessed the shooting death of protester Ashli Babbitt, and the Twitter account for Insurgence USA retweeted video from *someone with Sullivan* that shows the shooting and the aftermath.**

**“I have video of it,” he said, describing in detail seeing the flash of the gun, the bullet strike Babbitt, and Babbitt’s reaction as she died there on the floor.** “I am hesitant to post it. ... It’s something I have to take in. I hope that people get a grasp of that situation. Whoever shot her, maybe should be held accountable. I guess that’s up to the law to decide.”

He claims Babbitt was the first one to try and get inside the House chamber.

“There was a glass wall, and she, the woman, was the first person to actually try to get inside,” Sullivan said. “All you see is hands come out the doorways with their guns. ... You don’t see their face, nothing. And I literally yell at everybody else, ‘There’s a gun! There’s a gun! Don’t go in there!’ And a shot goes off. And she gets shot as soon as she goes through.”

**In the wake of widespread condemnation, including from some lawmakers who support Trump and had planned to object to the electoral votes, there were assertions that those who stormed the Capitol, fought with police and injured officers, ransacked offices, and damaged public property, were actually members of groups like Antifa or Black Lives Matter. In fact, Sullivan's picture was circulating on social media as "evidence" that the rioters were not Trump supporters.**

**Sullivan said that while he is not a Trump supporter, he wasn't there to join the protest, only to listen and document, and he saw no one else that aligned with his ideology in the crowd.**

**"I was probably the only person that supported BLM (Black Lives Matter)," he said. "I could say, from my knowledge ... there were just seas of Trump supporters, Proud Boys."**

**He said some of what they were yelling were insults about Antifa and Black Lives Matter.**

When he was asked if he was a member of Antifa, as he has used the hashtag in his social media posts, he said he understands where there could be confusion.

"If people are saying I'm Antifa, as far as a terrorist organization, I'm not," he said. "Am I anti-fascist? We all are anti-fascist. And that's what we should all strive for being. I have my own organization, Insurgence USA, and that's what it is for. That's really what it is."

He said he documented the rally as it began near the Washington Monument and "migrated over to the Capitol."

**"There were all of these people just listening to Trump, and then they just marched," Sullivan said. "It's not like a new group joined, another group came. They literally came from the MAGA protest, where Trump was, and went over there. There was no Antifa."**

**He said he even recognized some people from other pro-Trump rallies.**

**"They're the same people," he said. "They were flying Confederate flags, they were flying blue lives matter flags, Trump flags, and all of that."**

He said the protesters who stormed the Capitol were all ages and genders.

"There were kids, there were women, there were old, old men," he said, "and **they were all participating in this insurrection** at the ... Capitol. ... It should awaken you to the anger that people might have that's seriously, you know, a problem. And maybe they need to address it."

Sullivan, 26, faces two criminal charges stemming from a protest he organized in Provo last June.

Charging documents say Sullivan recorded several hours of the protest and is seen in the recordings "kicking vehicles and threatening drivers" and directing protesters to block intersections.

During that protest, a Provo man, 60, was shot in the elbow after protesters blocked his vehicle. **Sullivan later admitted to police that he knew who the gunman was but failed to report it to authorities, according to the charges.**

WASHINGTON -- A police officer has died from injuries sustained as President Donald Trump's supporters stormed the Capitol, a violent siege that is forcing hard questions about the defeated president's remaining days in office and the ability of the Capitol Police to secure the area.

The U.S. Capitol Police said in a statement that Officer Brian D. Sicknick, 42, was injured "while physically engaging with protesters" during the Wednesday riot. He is the fifth person to die because of the melee.

The brother of Officer Sicknick released the following statement to ABC News: "After a day of fighting for his life, he passed away a hero. I would like to thank all of his brothers and sisters in law enforcement for the incredible compassion and support they have shown my family. My family and I hope that our privacy can be respected as we grieve. Thank you."

House Speaker Nancy Pelosi order the flags at the Capitol to be lowered to half-staff in the wake of Sicknick's death.

"On behalf of the House of Representatives, I send our deepest condolences to the family and loved ones of Officer Brian Sicknick, who died after defending the Capitol complex and protecting those who serve and work here. The perpetrators of Officer Sicknick's death must be brought to justice," she said in a statement."

The U.S. attorney's office in D.C. has opened a federal murder investigation into Sicknick's death, three law enforcement sources confirmed to ABC News.

The investigation is currently being conducted jointly between the FBI and the D.C. Metropolitan Police Department, with cooperation from the U.S. Capitol police.

The first comment from the White House on the officer's death came in a written statement from Deputy Press Secretary Judd Deere: "Anytime a member of law enforcement dies in the line of duty it is a solemn reminder to us all that they run toward danger to maintain peace. The President and the entire Administration extend our prayers to Capitol Police Officer Brian Sicknick's family as we all grieve the loss of this American hero."

The rampage that has shocked the world and left the country on edge forced the resignations of three top Capitol security officials over the failure to stop the breach. It led lawmakers to demand a review of operations and an FBI briefing over what they called a "terrorist attack." And it is prompting a broader reckoning over Trump's tenure in office and what comes next for a torn nation.

Protesters were urged by Trump during a rally near the White House earlier Wednesday to head to Capitol Hill, where lawmakers were scheduled to confirm Biden's presidential victory. The mob swiftly broke through police barriers, smashed windows and paraded through the halls, sending lawmakers into hiding.

One protester, a white woman, was shot to death by Capitol Police, and there were dozens of arrests. Three other people died after "medical emergencies" related to the breach.

**Despite Trump's repeated claims of voter fraud, election officials and his own former attorney general have said there were no problems on a scale that would change the outcome. All the states have certified their results as fair and accurate, by Republican and Democratic officials alike.**

Sen. Ben Sasse, R-Neb., said news of the police officer's death was "gut-wrenching."

"None of this should have happened," Sasse said in a statement. "Lord, have mercy."

Sicknick had returned to his division office after the incident and collapsed, the statement said. He was taken to a local hospital where he died on Thursday.

Two House Democrats on committees overseeing the Capitol police budgets said those responsible need to be held to answer for the "senseless" death.

"We must ensure that the mob who attacked the People's House and those who instigated them are held fully accountable," said Rep. Rosa DeLauro, D-Ct., and Rep. Tim Ryan, D-Ohio. in a statement.

Earlier Thursday, House Speaker Nancy Pelosi said any remaining day with the president in power could be "a horror show for America." Likewise, Senate Democratic leader Chuck Schumer said the attack on the Capitol was "an insurrection against the United States, incited by the president," and Trump must not stay in office "one day" longer.

**Pelosi and Schumer called for invoking the 25th Amendment to the Constitution to force Trump from office before President-elect Joe Biden is inaugurated on Jan. 20.** Schumer said he and Pelosi tried to call Vice President Mike Pence early Thursday to discuss that option but were unable to connect with him.

At least one Republican lawmaker joined the effort. The procedure allows for the vice president and a majority of the Cabinet to declare the president unfit for office. The vice president then becomes acting president.

Pelosi said if the president's Cabinet does not swiftly act, the House may proceed to impeach Trump.

Trump, who had repeatedly refused to concede the election, did so in a late Thursday video from the White House vowing a "seamless transition of power."

Two Republicans who led efforts to challenge the election results, Ted Cruz of Texas and Josh Hawley of Missouri, faced angry peers in the Senate. Cruz defended his objection to the election results as "the right thing to do" as he tried unsuccessfully to have Congress launch an investigation. In the House, Republican leaders Rep. Kevin McCarthy of California and Rep. Steve Scalise of Louisiana joined in the failed effort to overturn Biden's win by objecting to the Electoral College results.

With tensions high, the Capitol shuttered and lawmakers not scheduled to return until the inauguration, an uneasy feeling of stalemate settled over a main seat of national power as Trump remained holed up at the White House.

**The social media giant Facebook banned the president from its platform and Instagram for the duration of Trump's final days in office, if not indefinitely, citing his intent to stoke unrest. Twitter had silenced him the day before. Facebook founder Mark Zuckerberg said "the shocking events" make it clear Trump "intends to use his remaining time in office to undermine the peaceful and lawful transition of power."**

U.S. Capitol Police Chief Steven Sund, under pressure from Schumer, Pelosi and other congressional leaders, was forced to resign. Senate Majority Leader Mitch McConnell asked for and received the resignation of the Sergeant at Arms of the Senate, Michael Stenger, effective immediately. Paul Irving, the longtime Sergeant at Arms of the House, also resigned.

Sund had defended his department's response to the storming of the Capitol, saying officers had "acted valiantly when faced with thousands of individuals involved in violent riotous actions."

Washington Mayor Muriel Bowser called the police response "a failure."

Lawmakers from both parties pledged to investigate and questioned whether a lack of preparedness allowed a mob to occupy and vandalize the building. The Pentagon and Justice Department had been rebuffed when they offered assistance.

**Black lawmakers, in particular, noted the way the mostly white Trump supporters were treated. Newly elected Rep. Cori Bush, D-Mo., said if "we, as Black people did the same things that happened ... the reaction would have been different, we would have been laid out on the ground."**

The protesters ransacked the place, taking over the House area and Senate chamber and waving Trump, American and Confederate flags. Outside, they scaled the walls and balconies.

Rep. Val Demings, D-Fla., a former police chief, said it was "painfully obvious" that Capitol police "were not prepared."

- 3) President Biden, on the other hand, is deeply [intertwined with China](#)...  
...both directly (watch [this video](#)) and [via his son, Hunter](#)...  
Joe Biden has never had a harsh word to say against China... Just try to find one...  
Instead, we get [this](#)...  
Truly, we should think of President Biden as our country's first *real* [Manchurian Candidate](#)...  
Given his state of mental decline, I'm sure he will be very pliable...

- 4) The Mainstream media and the New Media have clearly established themselves as kingmakers...  
Even before the election, they had every economic reason to kowtow to China...  
...with its 1.4 billion potential customers...  
...but now, during the 2020 election cycle, they also came up with a new and valuable service...
